2025 Street Opening Moratorium

Roads resurfaced or reconstructed shall be subject to a street opening moratorium, except under emergency conditions as determined by the Superintendent of Streets in accordance with the Town General Bylaws – *Chapter 32 Streets and Sidewalks*. Roadways resurfaced or reconstructed are subject to a three-year moratorium. In such circumstances, the Department of Public Works may require permanent patches to be made with specialized treatment (i.e. infra-red, microwave, curb-to-curb, or other process). Any of the above may be required to ensure integration of the patch to the existing bituminous surface in a uniform and seamless manner. The Superintendent of Streets will consider petitions to waive the moratorium on a case-by-case basis.
