2. List ALL family/household members at this address. Include any member of the family in the military service, away at school or in a nursing home. If a new member has been added to the household, enter their information on a blank shaded line at the end of the form.
3. **DATE OF BIRTH:** "MM=month, DD=day, YYYY=year"
4. **OCCUPATION:** Enter the title, not the place of employment.
5. **NATIONALITY:** Only complete if NOT a US CITIZEN
6. **VETERAN:** Check if you are a Veteran of the US Armed Forces
7. **MOVED:** If the person has moved, mark "M" in the column and draw a line through the name of any resident no longer residing at this address. If the person is a voter, and can sign the front of the form, that they no longer live in Oxford he/she will be removed. If the voter is unable to sign, a separate mailing will be sent to them at a later time in order for them to be removed from the active voter rolls for this address.
8. **DECEASED:** If the person is deceased, mark "D" in the column.

On the welcome screen Select "Dog License"

Make your selection from the drop down and follow the prompts (choose neutered or spayed if fixed)

Electronic Check: You will need to provide your account number and the bank's routing number. You will be shown where this information is on your check. There will be a \$.50 fee per transaction.

Credit Card: For MasterCard and Discover credit card payments there is a convenience fee of \$2.50 for each online payment. For VISA there is a convenience fee of \$3.95. The credit card service provider charges the fee to your credit card. The fee amount will appear in a separate box and will be totaled with the amount of the payment.

RENEW DOG LICENSES BY MAIL

Complete the enclosed application. Mail the form, required documents, a SASE(self-addressed stamped envelope) and a check or money order, made payable to the "Town of Oxford" to: Office of the Town Clerk, 325 Main Street, Oxford, MA 01540. Please be advised that Veterinarian Hospitals are required to send rabies information to all City or Town Clerk's Offices in the Commonwealth. If you have recently moved or your dog is no longer in your household, it is best to notify the Veterinarian Hospital so they may update their records with the correct information.
